Municipal waste management in Cyprus: Challenges and response measures



The **coordination of actions** in the municipal waste management between Central Government and Local Authorities is considered crucial for Cyprus' compliance with the **objectives** set for municipal waste management per the European and National environmental legislation.

face, taking into account:

- the low performance, in relation to the high European targets set for the preparation of municipal waste for reuse / recycling
- the disproportionately higher per capita rate of waste generation
- the high percentage (80%) of the produced quantities of waste, which ends up in disposal sites (landfill, IWMF)

In the EU Early Warning reports of 2019 and 2022, some recommendations are mentioned to deal with the above challenges, one of which is the establishment and operation of a Coordinating Body between the Central Government and the Local Authorities to achieve a rational management of the solid municipal waste.






KICK - OFF MEETING

On April 28th, 2023, the Kick-Off Meeting was held to inform all parties involved in the municipal waste management, regarding the initiation of a recommendation study for the establishment and operation of a Coordinating Body between the Central Government and the Local Authorities, with the aim of **facilitating the implementation of the** municipal waste management policy.

At the meeting, the critical points and questionnaire results were presented, regarding the creation and establishment of this administrative structure, and the views of the involved bodies were discussed, regarding the responsibilities and tasks that will frame the operation of this Coordinating Body.




Conducting Regional Workshops using the participatory process method


